**Minutes of
Regular Business Meeting
TEXAS ALLIANCE OF GROUNDWATER DISTRICTS
May 18-19, 2016
Crowne Plaza, Austin, TX**

These Minutes are a record of the items discussed, including motions on any matters that involve the TAGD Membership. The Minutes mostly follow the order on the previously distributed agenda, but may not have been discussed in that order, as noted in the Minutes.

- A. Call to Order and Invocation.** President Joe B. Cooper called the meeting to order at 2:02 PM on May 18, 2016. David Bailey gave the invocation.
- B. Speaker Sessions.**
- Record Management – Valerie Littleton & Nichelle Cunningham, EAA
 - RMBJ Introduction – Amy Bush
- C. Roll Call.** Secretary Leah Adams called the roll and informed the President that 54 District Members were in attendance, comprising a quorum. A list of GCDs represented at the meeting is attached as Attachment 1. Ballots for the open position of Parliamentarian were passed out during the roll call. Joe B. Cooper asked that all ballots be turned in to Beth Hood before 3:00 PM.
- D. Membership update and announcement of new members.** Joe B. Cooper announced that since the last meeting TAGD has accepted and processed four new Associate Members, with 1 additional new associate member application currently in process.
- E. TAGD Parliamentarian Election.** Joe B. Cooper introduced the candidates for parliamentarian and provided the membership with a review of the Nominating Committee's selection process. Adeline Fox and Bob Patterson were each asked each to say a few words on their candidacy. Joe B. Cooper called for any floor nominations. None were received. .
- F. Discussion and possible action on minutes of prior meeting.** Joe B. Cooper presented the minutes from the last meeting. David Van Dresar made a motion to accept the minutes as presented. Judy Parker seconded the motion. The motion passed unanimously.
- G. Discussion and possible action on Q2 financial reports.** Joe B. Cooper introduced Treasurer Zach Holland to present the Q2 financial reports. After presentation of the reports and discussion, Steve Walthour moved to accept Q2 finances as presented, and Mike McGuire seconded the motion. The motion passed unanimously.
- H. Discussion and possible action on health insurance monthly & group plan.** Executive Director Sarah Schlessinger provided the membership with a review of TAGD's policy on health insurance benefits for staff. Sarah Schlessinger stated that instead of providing a taxable monthly stipend for health insurance, TAGD would like to buy a group plan from BC/BS, which would increase the monthly cost of insurance. Treasurer Zach Holland provided the Finance Committee and Executive Committee's recommendation to increase the monthly maximum and move to a group health insurance plan. After some discussion, Ron Fieseler

made the motion and Gary Westbrook seconded the motion to increase the monthly maximum from \$450 to \$550 and to move to the presented group plan. The motion passed unanimously.

- I. Discussion and possible action on Employment Policy Amendments.** Zach Holland presented the proposed amendment to the employment policy. Sarah Schlessinger stated that the changes were presented to the membership via email in accordance with the TAGD bylaws. Gary Westbrook moved to approve the Employment Policy amendment as presented. David Mauk seconded the motion. Discussion resulted in recommendation that the Bylaws Committee look at cleaning up Employment Policy before next meeting. The motion passed unanimously.
- J. Discussion and possible action on Record Retention & Destruction Policy.** Sarah Schlessinger presented the new proposed Record Retention & Destruction Policy to the membership. Sarah stated that the new policy was presented to the membership via email in accordance with the TAGD bylaws. Diana Thomas provided three editorial amendments for consideration. After some discussion, Mike McGuire made the motion to approve the policy as amended. Judy Parker seconded the motion. The motion passed unanimously.

- M. Groundwater Topics Caucuses: Permitting Issues, University Collaboration, GCD Performance Metrics.** Joe B. Cooper asked Sarah Schlessinger to introduce the caucus themes and room structure. Sarah Schlessinger presented the caucus objective to be an opportunity to hold a roundtable discussion with colleagues that you may not otherwise have a chance to have a dialogue with. Each caucus was directed to record its three main takeaways to present to the full membership at their conclusion.

Following the caucus reports, Joe B. Cooper recessed the meeting at 6:10 PM.

S. Officer and Committee Reports. Joe B. Cooper moved into committee reports as listed below:

1. Executive Director – Sarah Schlessinger gave the membership an employee update stating that Beth Hood’s position is now Program Manager. Sarah provided a report on her activities representing TAGD at various events, announced TAGD’s weekly and monthly newsletter, encouraged survey participation, reported on the Texas Groundwater Summit and field trip, and concluded with a report on her one year evaluation.
2. Executive Committee – Joe B. Cooper stated the committee meets about every 6 weeks. At the last meeting, the committee reviewed financials, health insurance, the Record Retention and Destruction Policy and completed Sarah Schlessinger’s employee review. Joe B. Cooper welcomed Adeline Fox as the newest member of the committee.
3. Legislative Committee – Dirk Aaron reminded everyone of the legislative committee meeting after the TAGD regular business meeting.
4. Bylaws Committee – Lonnie Stewart reported no update.
5. Groundwater Protection – David Van Dresar reported no update.
6. Drought Preparedness – David Van Dresar reported no update.
7. Information & Education – Leah Adams stated that 5 or 6 people had responded to the second salary survey and reminded everyone of the importance of the information. Beth Hood provided an update on the GCD Index and the University Collaboration Program.
8. Legislative Subcommittees – Doug Shaw with the Groundwater Planning Subcommittee stated the committee had responded to the preliminary request for stakeholder input on possible rule changes for TWDB. David Mauk with the GCD Administration and Accountability Subcommittee stated they are engaging an analysis GCD performance metrics to help get ready for the July hearing.

T. Member and GMA Reports. A representative from each GMA provided an update on where they stood in the process. All GMA’s had approved a proposed DFC and begun the public comment period. A few GCDs had completed the process and final submission to the TWDB.

U. Other TAGD Business. Joe B. Cooper opened up other TAGD business:

- a) Steve Walthour stated that the High Plains GCD will dedicate the Richard Bowers Conservation Learning Center on June 14 and invited everyone to attend.
- b) Gary Westbrook reminded everyone to be conscience of their words to provide a more accurate picture of unprotected areas and local representation.
- c) C.E. Williams reminded everyone of the Groundwater Management conference in Fort Worth.
- d) Troupe Brewer provided the TAGD membership with an update on the Middle Pecos Groundwater Conservation District and pending legal issues.

V. Adjournment. Joe B. Cooper adjourned the meeting at 11:24 P.M.

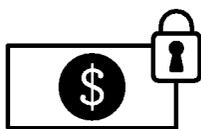
